Yasukuni Enoki - Former Ambassador of Japan to India

Mr. Enoki was born in Tokyo. He finished his university education from Faculty of Law, Tokyo University and joined in the Ministry of Foreign Affairs (MOFA) in 1968. In his long career as a diplomat, he has served in various posts including Director of International Division, Official Loan Assistance and the First Middle East Division. In 1990, he because Minister of Deputy Chief of Mission, Embassy of Japan in Australia and in 1993 Consul-General of Japan in Detroit, USA, followed by a significant stint as Minister and Deputy Chief of Mission, Permanent Mission of Japan to the European Union. After returning to Japan, he assumed the position of Director-General for Cultural Exchange Bureau as well as Director-General for Middle East and Africa. In 2001, he became Ambassador Extraordinary and Plenipotentiary of Japan to the Republic of South Africa, concurrently to Namibia, Botswana, Lesotho and Swaziland. In 2003, he became Ambassador Extraordinary and Plenipotentiary of Japan to India, concurrently to the Kingdom of Bhutan. In October 2007, Mr. Enoki was retired from the Government, and joined the Mitsui Co., Ltd. as Counselor in November 2007.

Kakutaro Kitashiro - Senior Advisor, IBM Japan, Ltd.

Kakutaro Kitashiro is senior advisor of IBM Japan. He was appointed to the position in May 2007 after serving as chairman of the board of IBM Japan since 1999 and as president of IBM Japan since 1993. He also served as president of IBM Asia Pacific from November 1999 to March 2003. Mr. Kitashiro joined IBM Japan as a systems engineer trainee in 1967 after graduating from Keio University with a BS degree in engineering. He also holds an MS degree in electrical engineering and computer science from the University of California at Berkeley in 1972. Mr. Kitashiro held several management positions before becoming an administrative assistant to IBM CEO John R. Opel in July 1983. In January of the following year, he became administrative assistant to Takeo Shiina, president of IBM Japan. He held a number of executive positions before being named IBM Japan vice president of marketing and services in March 1991, prior to becoming president of IBM Japan in 1993. Mr. Kitashiro served as chairman of KEIZAI DOYUKAI (Japan Association of Corporate Executives) from April 2003 to April 2007. He has been promoting a concept of Innovation. He is also a member of National Public Service Ethics Board of the National Personnel Authority.

Dr. Kiyoshi Kurokawa - Former WHO Commissioner, Medical Authority

A physician and professor of medicine at UCLA, the University of Tokyo and Tokai University who has healed bodies on both sides of the Pacific for decades, Dr. Kiyoshi Kurokawa has also immersed himself in the business of science policy and innovation. From 2005-2008, he was the WHO Commissioner for Social Determinants of Health. As science advisor to Japan's Cabinet for the past two years, he spearheaded programs meant to better focus the country's pursuit of innovation. Dr. Kurokawa is a vocal advocate of setting objectives to ensure that Japan becomes a net exporter of food and clean energy by 2030.

Tatsuo Okada, Ph.D.

Executive Director, NPO Global Sports Alliance, Chairman, Environment Committee, Japan Sailing Federation

Dr. Okada is the founder and Executive Director of NPO Global Sports Alliance (GSA) established in 1999 in Japan. GSA is a non-profit organization, and a network of people who love sports and outdoor activities, aiming to leave a healthy environment for future generations by spreading a new concept of "Ecoplay" as a fundamental part of sportsmanship. "Ecoplay" means to enrich nature, save energy, and reduce material consumption. The program to realize the mission is "Ecoflag Movement" and its working formula is:

Power to change = People x Awareness x Action

GSA consists of Players, Partners, and Supporters. GSA Players around the world are working to partner with schools and sport organizations, and to gain the support of event sponsors, to fly the "Ecoflag" at their sporting events and spread the concept of "Ecoplay." William Saito - Award Winning Entrepreneur, Data Security Expert, Tech Wizard Named Entrepreneur of the Year in 1998 by Ernst & Young, NASDAQ and USA Today, William Saito is an ubergeek who's as comfortable in the boardroom as he is in the lab. An encryption, authentication and biometric technology expert, William made his first company, I/O Software, Inc., a global leader in security software development. He later started InTecur, a consultancy that helps companies identify and market innovative technologies. He devised the world's first biometric authentication system with Sony, and subsequently licensed the programming interface to Microsoft and over 140 other companies. William has testified before Congress, and currently advises the FBI, Japan's National Institute of Advanced Industrial Science and Technology and similar institutions.

Aftab Seth - Former Ambassador of India

Ambassador Seth was born in Patna, Bihar, India on 1943. He acquired M.A. in History and Politics in Oxford University in 1964. He long served for Foreign Service in India and had distinguished work in Beirut, Cairo, Hamburg, Jakarta, Karachi and he served as an Ambassador to Greece in 1992-1996, Vietnam in 1997-2000, and Japan and Federal State of Micronesia concurrently in 2000-2003. In 2004, he became a Professor and Director of Global Security Research Institute, Keio University. In 2006, he worked as Chairman of the International Advisory Committee and Professor of Global Security Research Institute in Keio, and now he is an International Advisor in Keio. From 2006 to present, he is also the Chairman & CEO of India Global Link Co., Ltd., the Chairman of Japan-India Partnership Forum, and the Chairman of Sun Link Co., Ltd. He also actively works as an author and a well-known poet. He has received applause at his critical writing on Japanese politics and economics by many intellectuals such as the Governor of Tokyo.

Ken Shibusawa - Chairman, Commons Asset Management

Ken Shibusawa founded the Japanese mutual fund company in 2008, and in 2009 launched the Commons 30 Fund, dedicated to deliver long term investments to the Japanese household. He also founded the advisory firm, Shibusawa and Company, specializing in alternative investments in 2001. He has extensive experience in the financial markets at Moore Capital, a US hedge fund, as well as US investment banks such as JP Morgan and Goldman Sachs. In addition, he is also an independent director of eAccess (listed-TSE 1), and Bridge Capital Securities. His non-profit activities include: board of directors at the Shibusawa Eiichi Memorial Foundation, director of the Keizai Doyukai (Japan Association of Corporate Executives), board of directors at the Healthcare Policy Institute Japan, and board of directors at the Institute for Health Outcomes & Process Evaluation Research. He has also published author and writes frequently in magazines, journals, and internet media.
